Furthermore, she was active as an associate for Patterson, Belknap, Webb & Tyler as well Tunstead, Schechter & Torre between 1986 and 1991. Ms. Sigmond was also associated with Berman, Paley, Goldstein & Kannry, in New York City for two years.

In preparation of her profession, Ms. Sigmond pursued a formal education at Grinnell College in Iowa and earned a Bachelor of Arts in 1972. A short time later, she obtained a Doctor of Jurisprudence from the Catholic University of America in 1975. Moreover, Ms. Sigmond was admitted to practice law by the Virginia State Bar, the District of Columbia Bar, the U.S. District Court for the Eastern District of Virginia, and the U.S. District Court for the D.C. Circuit. Additionally, she has represented cases in front of the U.S. District Court for the District of Maryland, the U.S. District Court for the Southern and Eastern Districts of New York, the U.S. Court of Appeals for the Second, Fourth and Federal Circuits, the Federal Claims Court, and the Court of International Trade.

In order to remain current on trends in the legal field, Ms. Sigmond maintains professional ties with the New York State Bar Association, the New York City Bar Association, and the Woman's National Democratic Club. The highlight of her career was her farewell address to the New York County Lawyers Association at the end of her term as their president. While it was a sad moment for her, it also allowed her to reflect on her time with the organization.
